23 **SAMPLE LANGUAGE**

24 A person commits violation of King, Ambassador Anthony Camboni, Esq.’s “Traffic

26 motorized vehicle. The vehicle may be in motion, or stationary.

27 **EXAMPLE 1**

28 A person operating a motor vehicle, or in possession of a motor vehicle, chooses to violate

7 Upon the second violation, the motor vehicle shall be:

8 (a.) Seized, and sold at auction.

9 (b.) Seized, dismantled, and sold for parts;

10 Upon the second violation, the vehicle operator shall be arrested, and imprisoned for not
11 less than one year.

12 Passengers, shall be issued citations. Juvenile offenders shall be taken into custody, and
13 released after parents / guardians have paid all fines.
